## WHAT IS COORDINATED ENTRY?

Coordinated Entry (CE) refers to the practice of conducting in-depth assessments of needs and barriers of people experiencing homelessness or at imminent risk of homelessness.

#### HOW CAN PARTNER AGENCIES JOIN IN AND HELP OUT?

The **Coordinated Entry Advisory Committee** (CEAC) are members who can provide insight into the many experiences and perspectives of people in our community experiencing homelessness.

- Approving policy and procedure recommendations from the CE Workgroups to improve the efficiency and effectiveness of CE
- Working with the coordinating entity (One Roof) to identify any policy implications in changes to the daily operations
- Advising One Roof based on the review of CE system performance data and recommending innovative solutions to improve outcomes
- Holding accountability and providing support to One Roof for fulfilling the CE vision

### WHAT DOES IT MEAN TO BE PART OF A WORKGROUP?

The **CE Referral and Prioritization Workgroup** will focus on analyzing data to determine improvements for the CE referral and prioritization process.

- Reviewing and updating CE referral response data and current CE referral protocols
- Evaluating CE assessment data and housing outcome data reports provided by the CE Data Workgroup
- Analyzing data to determine changes to CE prioritization methods for housing placement

The **CE Partnership Workgroup** will focus on creating recommendations to support housing agencies through the CE System.

- Creating a recommendation report to support housing agencies in strengthening relationships with supportive services and implementing peer support
- Reviewing CE's internal referral workflow to connect clients to supportive services
- Strengthening the referral process to supportive services between agencies

### HOW ELSE CAN PARTNER AGENCIES GET INVOLVED?

The **CE Monthly Referral Discussion Meeting** is a client case conferencing meeting to discuss hard to house clients currently on the CE list or clients who have been referred to a partner housing agency.

The **CE Outreach Collaboration Meeting** is a monthly meeting to form a stronger relationship between agencies working towards ending homelessness, share and explain new and existing resources with each other, and case conference street clients to better serve them and the community.

### WHAT ELSE IS ONE ROOF DOING TO IMPROVE THE COORDINATED ENTRY SYSTEM?

In addition, One Roof team members have created an internal **CE Data Workgroup** which focuses on reviewing raw coordinated entry data to identify correlations between client barriers and housing outcomes.
